

Practical Dental Assisting of Utah

DISCLOSURE STATEMENT

By signing below you understand the following:

1. You are enrolling as a student of Practical Dental Assisting of Utah, located at 389 West 600 North, Lindon, UT 84042.
2. You are aware that the course is taught in a functioning dental office. You are aware that all the equipment used in this functioning office is at your disposal as part of the learning experience, although you are required to handle all equipment with care and common sense. You are aware that the instructors of the program are a Doctor of Dental Surgery and Dental Assistants/Hygienists.
3. You are aware that the Dental Assisting course will last for 12 consecutive Saturdays, not including holidays or breaks. You are aware that the hours of the course are 8:30am to 4:00pm on each of those days enrolled. Classes are also offered Monday and Wednesday evenings from 6-9:30pm for 12 consecutive weeks. You are aware that the Administration course will last for 12 consecutive Thursdays, not including holidays or breaks. You are aware that the hours of the course are 6:00pm to 9:00pm on each of those days enrolled.
4. You are aware of the minimum enrollment requirements; including: a) you have attained a high school diploma or equivalent GED certification and b) you are beyond the age of compulsory high school attendance.
5. You are aware that this program does not offer a CDA (Certificate of Dental Assisting), but rather a Certificate of Graduation from Practical Dental Assisting of Utah.
6. You are aware that upon completion of the program you will be certified in radiology and exposure per the State of Utah requirements, if the Radiology Exam is passed with at least an 80%.
7. You are aware that the cost of the Dental Assisting course is **\$3,495**. You are aware that this fee covers texts, supplies, materials and all other miscellaneous expenses. You are aware that the cost of the Administration course is **\$1,995**. You are aware that this fee covers texts, supplies, materials and all other miscellaneous expenses. You are also aware that if you wish to enroll in both courses that the combined tuition is **\$3990**.
8. You are aware that you may cancel your enrollment at any time before the first day of class or anytime within three business days of your tuition payment for a full refund. You are aware of the refund policy printed on the application form.
9. You are aware that graduation from the course is based upon 100% attendance (with make-ups allowed for absence) as well as 70% or better on midterm and final exams.
10. Practical Dental Assisting of Utah will maintain, to the best of its ability, employment and graduation rates for all attendees for the preceding three years. These rates may be obtained upon request by sending to: Practical Dental Assisting of Utah, 389 West 600 North Lindon, UT 84042.
